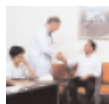

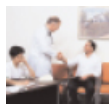

Safety Goals	Organizations Should	Implemented
Improve the accuracy of resident identification.	Use at least two resident identifiers when providing care, treatment or services.	<input checked="" type="checkbox"/>
	Prior to the start of any surgical or invasive procedure, conduct a final verification process, (such as a "time out,") to confirm the correct resident, procedure and site, using active—not passive—communication techniques.	<input checked="" type="checkbox"/>
Improve the effectiveness of communication among caregivers.	For verbal or telephone orders or for telephonic reporting of critical test results, verify the complete order or test result by having the person receiving the information record and "read-back" the complete order or test result.	<input checked="" type="checkbox"/>
	Standardize a list of abbreviations, acronyms, symbols, and dose designations that are not to be used throughout the organization.	<input checked="" type="checkbox"/>
	Measure and assess, and if appropriate, take action to improve the timeliness of reporting, and the timeliness of receipt by the responsible licensed caregiver, of critical test results and values.	<input checked="" type="checkbox"/>
	Implement a standardized approach to "hand off" communications, including an opportunity to ask and respond to questions.	<input checked="" type="checkbox"/>

	A complete list of the resident's medications is communicated to the next provider of service when a resident is referred or transferred to another setting, service, practitioner or level of care within or outside the organization. Reduce the risk of resident harm resulting from falls.	Implement a fall reduction program including an evaluation of the effectiveness of the program.	<input checked="" type="checkbox"/>

Safety Goals	Organizations Should	Implemented
	Develop and implement a protocol to identify new cases of influenza and to manage an outbreak.	
Encourage residents' active involvement in their own care as a resident safety strategy.	Define and communicate the means for residents and their families to report concerns about safety and encourage them to do so.	
Prevent health care-associated pressure ulcers (decubitus ulcers).	Assess and periodically reassess each resident's risk for developing a pressure ulcer (decubitus ulcer) and take action to address any identified risks.
