




Federal regulations waive the one-year history of addiction for these special populations, because these individuals are susceptible to relapse to opioid addiction, leading to high-risk behaviors with potentially life-threatening consequences. These populations include the following: Persons recently released from a penal institution Persons recently discharged from a chronic care facility Pregnant women Previously treated patients
